# Juan Campos (Juan Wayne) SAA

- Called meeting to order.
- Asked everyone to keep chatter to a minimum as we have a lot on the agenda today.

# Dave Godfrey (Limey) President

- Opened meeting and welcomed members.
- Sign-In Sheet going around and 50/50 being sold.
- Reminded Sponsors to keep Hangarounds/Prospects informed as necessary of club events and activities.
- We have a lot to cover today as well as Officer Elections and Bylaw Change Proposals
- Members running for office today include:
  - President Dave Godfrey (Limey) / Unopposed
  - o Vice President Brandon Davidson (Brando) / Kevin King (Slo-Hand)
  - Treasurer Kalan Binder (B-Dazzle) / Unopposed
  - Secretary Juan Campos (Juan Wayne) / Mike Allen (Tex)
- Ballots were passed out to members present.
- Candidates for Vice President and Secretary were asked to stand up and give their reasons for running for that officer position and they each did.
- Prior to voting Mark Mabile (Sarg) National SAA read the duties of the President and asked both Brando and Slo-Hand if there was anything that may prevent them from stepping into the role of President should that be necessary – they both answered No.
- Marc LeBlanc (Tipsy) Director thanked Tim Callais (Flaco) Secretary for his time of service as Secretary.
- Ballots were collected for counting by Patty Lenhart (Pattycake) Election Committee Chairman for counting.
- Next agenda item is the Proposed Bylaw Changes, Limey went through the logistics of the Bylaw
  Change Proposals, reviewed the current language in the bylaws, gave his opinion that the way it
  was handled at the November meeting was not within the spirit of the bylaws although the
  exact statement in the bylaws is not clear to the intended spirit of the bylaws regarding
  proposed changes. Mark Mabile (Sarg) National SAA also commented on the spirit of the bylaws
  regarding proposed changes.
- Stated that the officers had a meeting on 1/14 and have proposed a bylaw change that would clear up the process for proposing changes and has been added to the ballots.

- The proposed bylaw change ballots were passed out to the members present and included the following:
  - Number 1 A member in good standing shall attend a minimum of 4 meetings in a calendar year unless out for a job or family event that does not allow for that Member to attend the 4-meeting minimum – Juan Wayne.
  - Number 2 Add a background check requirement in the Prospect phase, prior to being voted on as a full patched Member – Bulldog.
  - Number 3 Only current Members that have been fully patched for 2 years in good standing are eligible for nomination – Blue.
  - Number 4 Add a provision for an Old Lady patch Tex.
  - Number 5 Modify the elections section of the bylaws to move away from annual elections. The elected officers would remain in their roles until challenged by a full patched Member in good standing. Once challenged, the members of the chapter would then vote between the current officer and the member that has challenged his position Tex.
  - Number 6 Full patched Members that have a military status will be allowed to display this status on their cuts after they have provided proof (Driver's License, DD214, etc.) of this military status to the Officers – Bulldog.
  - Number 7 All proposed amendments must be submitted to the Secretary in writing 7 days prior to the November meeting or June meeting for an officer review – Houston Officers.
- Each proposed bylaw was reviewed individually by Limey and there were discussions by several members of the club including Gator, Blood, Tipsy, Bulldog, Tex, Sarg, Satch, Cat Daddy, Rocket, Timbo, Juan Wayne, Fraser and RJ.
- It was decided to withdraw proposals number 2 (due to not enough information concerning the scope, cost and logistics of this proposal and number 4 (due to a conflict with National bylaws)
